Shopping for light bulbs used to be simple, but today's market offers a wide range of energy-efficient options. ### LEDS

- ENERGY STAR®-rated bulbs use approximately 70% less energy than standard incandescent bulbs and last at least 25,000 hours—about 22 years of average household use.
- LED bulbs produce very little heat, cutting energy costs associated with home cooling and making them less likely to be a fire hazard, plus they are shatterproof, shock resistant and safe to touch.
- Many indoor models available with dimming.
- Some outdoor models available with automatic daylight shut-off or motion sensor.

### LED YARD LIGHT

- Delivers more lumens per watt than more traditional yard lights such as Mercury Vapor, High Pressure Sodium and Metal Halide.
- Lasts much longer than traditional yard lights, so it may be the last one you install.

### GET THE FACTS

When comparing lighting products, look for the Lighting Facts label, which is required on most lighting packages by the U.S. Federal Trade Commission. The label provides accurate information on the brightness (in lumens), energy used, rated life, and estimated annual energy cost of each product.

A copy of the sales receipt is required in order to have the rebate processed. Rebate will not exceed 50% of the actual cost of the bulb(s). Rebates must be submitted within 90 days of purchase.

\*Cooperative residential members are eligible for a \$30 rebate for LED fixture only (not the bulb) installed within the cooperative's service area. To qualify, the fixture must be ENERGY STAR® or DLC certified and fall between 50 and 100 watts for new installs or for replacing high-pressure sodium, metal halide, or mercury vapor fixtures.

Rebates are available for the purchase of new ENERGY STAR or DLC rated bulbs or fixtures. Rebate submittal must follow the guidelines as outlined by cooperative. Cooperative is not responsible for inaccurate information supplied by the bulb or fixture manufacturer. Rebates will be issued only for products on the current list of ENERGY STAR rated products as of the purchase date. ENERGY STAR occasionally removes products from qualifying lists, and cooperative will not rebate products that have been delisted as of the purchase date or are mislabeled as ENERGY STAR. To verify ENERGY STAR certification for appliances and lighting, visit [www.energystar.gov](http://www.energystar.gov) or call 1-888-STAR-YES. Rebate program is subject to change or cancellation without notice. Call your cooperative to verify rebate program status and availability of rebates.

### IMPORTANT:

- The bulb(s) or fixture(s) must be installed within cooperative's service territory.
- Incomplete forms will not be processed.
- Include a copy of the original dated sales receipt.
- Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to your cooperative.
